IMPORTANT INFORMATION FOR ADMISSION

ELIGIBILITY OF ADMISSION

BBA: (60 seats)

Senior secondary examination (10+2) of Board of School Education Haryana, CBSE, New Delhi or an equivalent examination with 45% marks in aggregate recognized by M.D. University, Rohtak.

OF

3 year professional diploma programme conducted by State Board of Technical Education, Haryana without passing English Hindi subject at 10+2 level for admission to BBA course or any other Board recognized by any State Government or Union Territory.

Lateral Entry (10% seats of sanctioned intake)

Candidates who have passed Diploma in Business Management or an equivalent examination approved by the State Board of Technical Education, Haryana with atleast 45% marks in aggregate.

BCA (40 Seats)

Senior Secondary Examination (10+2) of Board of School Education Haryana, Bhiwani with 45% marks in aggregate or an equivalent examination recognised by this University.

OR

Three years Diploma Course conducted by State Board of Technical Education or any other examination recognized by the State Board of Technical Education as equivalent thereto.

MBA: (60 seats)

Master or Bachelor degree/Shastri examination (New Scheme) of three year duration with atleast 50% marks in aggregate or any other examination recognized by M.D. University, Rohtak as equivalent thereto.

OR

Final examination conducted by the Institute of Chartered Accountants of India/Institute of Cost and Works Accountants of India/Institute of Company Secretaries.

The candidates have to submit the Admission form to the Institute's Office on or before the stipulated dates. Admissions will be made on the basis of merit in the qualifying examination. The office will display merit list in a transparent manner.

GENERAL INSTRUCTIONS

- 1. In case any candidate is found to have supplied false information, certificate, documents etc. or is found to have withheld or concealed any information in his/her Application Form, he/she shall be liable to be debarred from admission to the course.
- 2. If a candidate is admitted on the basis of the information submitted by him/her, which is found to be incorrect or false later on, his/her admission will be cancelled and all fees and other dues paid by him/her shall be forfeited. The University/ Institute may also take further action, as deemed fit, against the candidate and his/her guardian.
- 3. In case two or more candidates in merit list have equal marks, the candidate senior in age will be considered first.
- 4. All the rules and regulations for submission of migration certificate by the candidates who have passed the lower examinations from other Universities / Boards will be applicable as per the University Rules.
- 5. Ragging is a cognizable offence and therefore, strictly prohibited in the Institute. Each admitted student shall have to furnish two affidavits as per specimen given at Annexure- from himself/herself and his/her parent/guardian that he/she was never found guilty of ragging and shall not indulge in any act of ragging.
- 6. If any student seeks accommodation in the Hostel he/she has to follow the rules and regulations of the Hostel as specified.
- 7. Reservation of seats will be as per the reservation policy issued by Govt. of Haryana.
- 8. A candidate who has passed qualifying examination from the Universities of Haryana/ Board of School Education Haryana, Bhiwani will be considered a Haryana resident and he/she is not required to submit Haryana Resident Certificate. Other candidates for seeking benefit of Haryana resident should submit a certificate of Bonafide Resident of Haryana.
- 9. An official E-mail ID will be allotted and communicated to every regular student by the Institute for sending official communication to him/her.
- 10. If a student remains absent from the classes consecutively for one week in a month his/her name will be struck off from the rolls & he/she will have to seek readmission and his/her parents will also be informed.
- 11. A minimum of 75% attendance has to be obtained to appear in university examination.
- 12. All the students are required to follow rules and regulations of the Institute.
- 13. Dress code is to be maintained on all formal occasions and on every Monday, Wednesday and Friday.
- 14. The working hours of the Institute are from 9:00 a.m. to 4:30 p.m.
- 15. Appearing in internal exams is mandatory for all the students. Anybody abstaining from the same/ not attaining the requisite pass percentage in each subject will not be allowed to appear in the university examinations.
- 16. Students are liable to face strict disciplinary actions if found indulging in any of the following activities:
 - a. Misbehavior or use of obscene expression.
 - b. Disruption of teaching, administration, classes, seminars or any other activity of the Institute.
 - c. Forgery, alteration or misuse of the Institute's documents, records or letterheads.
 - d. Unauthorized entry, damages/pilferage of Institute's property.
 - e. Consumption of alcoholic beverages/drugs/smoking.
 - f. Cheating in the examination.
 - g. Irregular attendance.
 - h. Use of mobile phone in the Institute timings.
- 17. All legal disputes shall fall within the jurisdiction of Charkhi Dadri only.

18. Institute Dress Code for Monday, Wednesday, Friday and all formal occasions.

Summer : Grey Shirt, Black Trouser with Institute's Tie and Black Shoes.

Winter : Grey Shirt, Black Trouser and Black Blazer with Institute's Tie and Black Shoes.

All the candidates must bring the following Original Certificates/Documents/Testimonials with them at the time of admission:-

- 1. Matriculation/High School Certificate.
- 2. 10+2/Intermediate/Senior Secondary School Examination.
- Qualifying Examination Detailed Marks Card (DMC) (Graduation for MBA, 12th for BBA/BCA)
- 4. Copy of Aadhar Card and Family I.D.
- Character Certificate:
 - (a) Regular Candidates: Candidates who have passed their qualifying examination from College/Dept. as regular student are required to submit the Character Certificate from the head of the institution last attended.
 - (b) Private Candidates: Candidates, who have passed their qualifying examination as private candidate should submit their Character Certificate, duly signed by a First Class Magistrate.
- 6. Gaps in study: If any gap in studies exists, students may give reasons with documentary proof and affidavit.
- 7. Caste/category Certificate obtained from Competent Authority.
- 8. Haryana Residence Certificate in case of passing qualifying exam from any other Board/University outside Haryana.
- 9. Certificate in support of any other claim.
- 10. The candidate must submit two copies of each certificate, two latest passport size and one ticket size photographs.
- 11. Anti ragging Affidavits are to be submitted by both, students and parents respectively.

BAN ON RAGGING IN EDUCATIONAL INSTITUTIONS

The instructions for curbing ragging as conveyed by the UGC vide letter No. FA-I/97 (CPP-II) dated 7th July,2001 in view of the judgment of Supreme Court in Civil Writ Petition No. 656 of 1998 'Vishwa Jagriti Mission V/s Centre Govt.' given below shall be adhered to strictly:

Ragging in educational institutions is banned and any one indulging in ragging is likely to be punished appropriately, which punishment may include expulsion from the institution, suspension from the institution or classes for a limited period or fine with a public apology. The punishment may also take shape of (i) withholding scholarships or other benefits (ii) debarring from representation in events (iii) withholding results (iv) suspension or expulsion from hostel or mess, and the like (v) Lodging of FIR with the local police. If the individuals committing or abetting ragging are not/cannot be identified, collective punishment can be awarded to act as a deterrent.

Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness any other students, indulging in rowdy or undisciplined activities which causes or is likely to cause annoyance, hardship or psychological harm or to raise fear or apprehension thereof in freshers or junior students or asking the students to do any act or perform something which such students will not do in the ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student will be deemed an act of ragging.

Hon'ble Supreme Court of India in SLP(C) No. 24295/2004 in the matter of University of Kerala V/s Council of Principals, Colleges of Kerala and others has ordered that if any incident of ragging comes to the notice of the authority, the concerned student shall be given liberty to explain and if his explanation is not found satisfactory, the authority would expel him from the Institution.

Information Booklet/Leaflet for Freshers

Under 'the AICTE (Prevention and Prohibition of Ragging in Technical Institutions, Universities including Deemed to be Universities imparting technical education) Regulations 2009' and 'the UGC Regulations on Curbing the Menace of Ragging in Higher Educational Institutions, 2009'.

What constitutes Ragging: - Ragging constitutes one or more of any of the following acts:

- a. any conduct by any student or students whether by words spoken or written or by an act which has the effect of teasing, treating or handling with rudeness a fresher or any other student;
- b. indulging in rowdy or undisciplined activities by any student or students which causes or is likely to cause annoyance, hardship, physical or psychological harm or to raise fear or apprehension thereof in any fresher or any other student;
- c. asking any student to do any act which such student will not in the ordinary course do and which has the effect of causing or generating a sense of shame, or torment or embarrassment so as to adversely affect the physique or psyche of such fresher or any other student;
- d. any act by a senior student that prevents, disrupts or disturbs the regular academic activity of any other student or a fresher:
- e. exploiting the services of a fresher or any other student for completing the academic tasks assigned to an individual or a group of students.
- f. any act of financial extortion or forceful expenditure burden put on a fresher or any other student by students;
- g. any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestures, causing bodily harm or any other danger to health or person;
- h. any act or abuse by spoken words, emails, posts, public insults which would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to fresher or any other student:
- any act that affects the mental health and self-confidence of a fresher or any other student with or without an intent to derive a sadistic pleasure or showing off power, authority or superiority by a student over any fresher or any other student.

Actions to be taken against students for indulging and abetting ragging in Technical Institutions, Universities including Deemed to be Universities imparting technical education:-

- 1. The punishment to be meted out to the persons indulged in ragging has to be exemplary and justifiably harsh to act as a deterrent against recurrence of such incidents.
- 2. Every single incident of ragging a First Information Report (FIR) must be filed without exception by the institutional authorities with the local police authorities.
- 3. The Anti-Ragging Committee of the institution shall take an appropriate decision, with regard to punishment or otherwise, depending on the facts of each incident of ragging and nature and gravity of the incident of ragging.
- 4. a) Depending upon the nature and gravity of the offence as established the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following:-
 - (i) Cancellation of admission
 - (ii) Suspension from attending classes
 - (iii) Withholding/withdrawing scholarship/fellowship and other benefits
 - (iv) Debarring from appearing in any test/examination or other evaluation process
 - (v) Withholding results
 - (vi) Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
 - (vii) Suspension/expulsion from the hostel
 - (viii) Rustication from the institution for period ranging from 1 to 4 semesters
 - (ix) Expulsion from the institution and consequent debarring from admission to any other institution.
 - (x) Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
 - b) An appeal against the order of punishment by the Anti-Ragging Committee shall lie, In case of an order of an institution, affiliated to or constituent part, of the University, to the Vice-Chancellor of the University.
